QUALIFIED CHARITABLE DISTRIBUTIONS (QCDs)

If you are 70 ½ or older, you may be eligible to make a Qualified Charitable Distribution directly from your IRA to Every Child Lane County. For individuals 73 or older, and submit to Required Minimum Distributions (RMDs), a QCD can satisfy your annual RMD while potentially reducing your taxable income.

Please consult your financial advisor to determine whether a QCD is right for you. **To make a QCD, contact your IRA custodian to initiate a gift to Every Child Lane County.**

DONOR ADVISED FUNDS (DAFs)

A Donor-Advised Fund is a charitable giving account that allows you to support causes you care about over time. Contact your financial advisor to discuss if opening a DAF is right for you.

- Receive a charitable income tax deduction based on the fair market value of the gift (subject to IRS rules)
- Make a greater impact than you might through a cash donation
